European Tax Law

The programme has been designed to offer broad and in-depth knowledge of EU Tax Law. Students will be made familiar with the foundations of Fundamentals of International Tax Law, Tax Treaties and European Union Law, followed by core courses on direct taxation, indirect taxation and State Aid law. Students will have the option to focus their studies in particular on either one of these three fields. The programme will not only be taught on a high academic level, but it also trains students on a very practical level (e.g., presentation and writing skills).

Career prospects

Graduates will be provided with the knowledge and insight to work in positions with EU institutions, the government and in the private sector that require high-level theoretical and operational knowledge of EU Tax Law. It is expected that graduates will enter careers in private practice, with multinational companies, with the government (Ministry of Finance, Trade or Foreign Affairs, tax administrations and occasionally the judiciary), EU institutions and in academia.

International Tax Center Leiden

The Master of Advanced Studies in EU Tax Law at Leiden University is housed in the building of the International Tax Center Leiden.
