Many of our staff are prominent members of or contributors to organisations such as the World Bank, the International Swaps and Derivatives Association (ISDA), P.R.I.M.E. Finance, and various courts and regulatory bodies. Moreover, they advise organisations such as the European Commission, the European Securities and Markets Authority, the Netherlands Authority for the Financial Markets, and various government ministries. This will help you build a network for internships and professional contacts.

In addition to the theory you learn in the coursework, you will be trained in professional skills, including writing legal

briefs, negotiating a financial transaction and practicing law in moot courts. You will also be able to see the interaction between law and finance up close while participating in site visits to financial institutions and supervisory authorities.

CAREER PROSPECTS

As a graduate, you will be well prepared for positions in a variety of national and international organisations such as: financial institutions like banks and investment firms, financial supervisory authorities, inter-governmental agencies, law firms, the judiciary and arbitration courts. Many of our graduates also contribute to scholarship in this growing field by pursuing postgraduate or PhD research.
